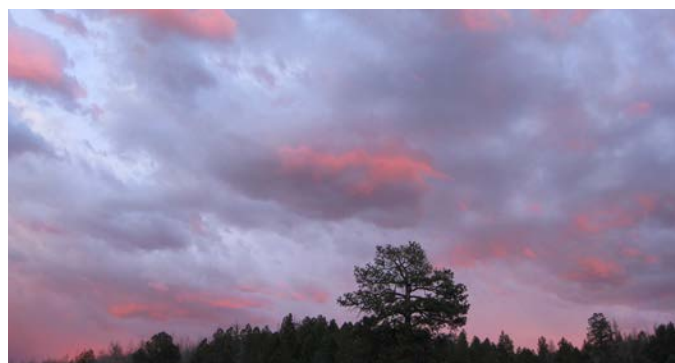
Transformation Awaits

Last week, it felt like the irresistible force of climate change was colliding with the immovable object of the fossil fuel industry here in New Mexico.

First, outgoing Land Commissioner Aubrey Dunn wrote to Ken McQueen, Secretary of the state Energy, Minerals and Natural Resources department, to express his concerns about hundreds of violations by oil and gas operators on state trust lands, including more than 500 wells that have ceased operation but not been cleaned up, littering the land with tank batteries, flow lines and other abandoned equipment.

Then, on November 19, the New Mexico Oil Conservation Commission voted to double the density of oil and gas wells permitted in the Four Corners region. The BLM plans to auction another 84,000 acres of federal public land for fracking on December 6, including 46,000 acres in the greater Chaco region.

Finally, late last week, the Fourth National Climate Assessment was released. The report provides a sobering and well-supported assessment of the impacts we can expect to feel from climate change over the coming years, from reduced water supplies to disappearing forests to decreased food production. Faced with the power and influence of the fossil fuel industry and the dire consequences of climate change that are already upon us, it is easy to feel discouraged and overwhelmed. But I believe that the scale of the transformation required of us can be a source of motivation, rather than despair.

This is our generation's moonshot, a great and inspiring work that can create a world in which future generations not only survive but thrive. Those of us who have engaged in hands-on acts of restoration know firsthand how profoundly fulfilling it is to work at repairing the world. Transitioning to less polluting forms of energy and building a more resilient society is work we can all be a part of.

We have fresh opportunities to do so with an incoming Governor and Land Commissioner who are committed to tackling climate change, reducing methane pollution, and expanding renewable energy in this land of wind and sun. We as citizens can do our part by urging our legislators and local elected officials to support these efforts, and lending our time and energy to organizations that are pushing for positive change.

The time for transformation is now, and the tools to begin are in our hands. Let's get busy.

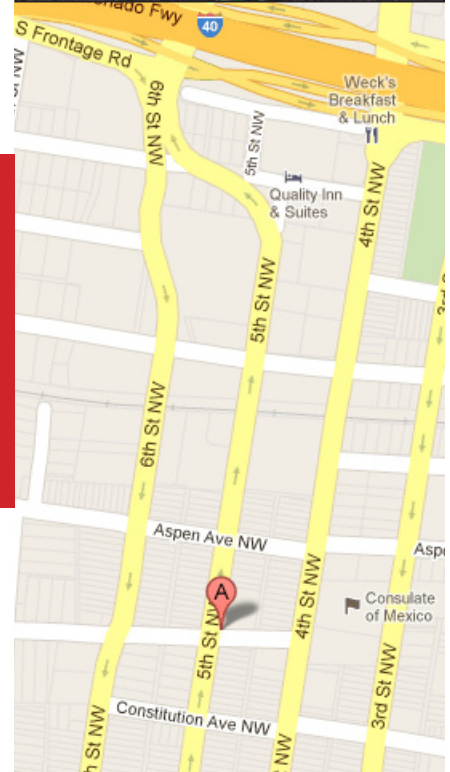
Time to renew your AWF membership!

The Albuquerque Friends Meeting House is located at the corner of 5th and Bellamah. From I-40, take the 6th street exit, then South to Bellamah.



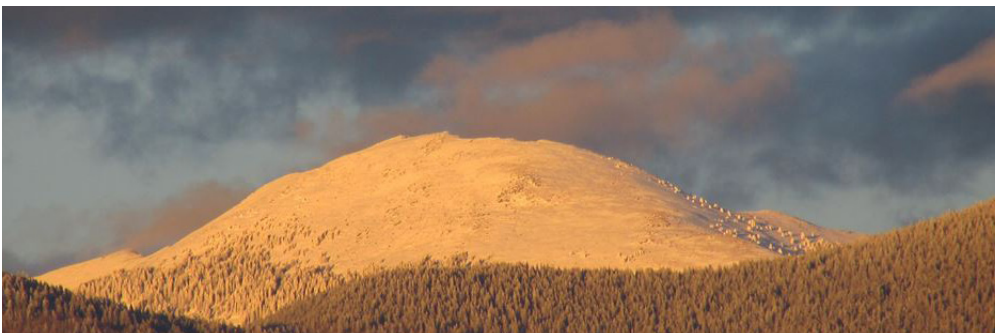

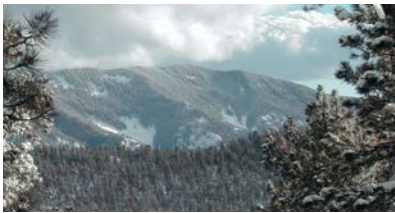
