## Progress Toward Protecting New Mexico's Wildlife

In the Albuquerque Wildlife Federation archives, there is a letter sent by Theodore Roosevelt to Aldo Leopold on January 18, 1917. In it, Roosevelt writes, "I have just read the Pine Cone. I think your platform simply capital, and I earnestly hope that you will get the right type of game warden."

At the time, Leopold and AWF's other founders were engaged in a fierce fight to secure the appointment of a qualified, nonpolitical state game warden who would rigorously enforce the state's hunting laws and prevent wild animals from being hunted to extinction.

The past few years have seemed like a return to the poor management that AWF's founders decried, with members of the New Mexico Game Commission organizing coyote killing contests, suing the federal government to try to halt the release of more Mexican gray wolves into the wild, and rejecting the State Wildlife Action Plan prepared by Game and Fish Department biologists because it supposedly included "too many" species in need of conservation.

Then, with last year's election of a new governor came new appointments to the game commission, and recent days have given reason to hope that New Mexico might be coming closer to having "the right type of game warden."

First, in late October the Game Commission voted unanimously to rejoin the Mexican gray wolf recovery effort,



partnering with the U.S. Fish and Wildlife Service, the Forest Service, the Bureau of Land Management, the Arizona Game and Fish Department, the White Mountain Apache Tribe, and others.

Then, the week before Thanksgiving came another unanimous vote in which the Game Commission banned cougar trapping for sport. It also reduced the number of cougars that can be hunted in certain parts of the state and banned traps and snares adjacent to public trailheads. Prior to the vote, New Mexico had been one of only two states in the continental U.S. that allowed cougars to be trapped using steel-jawed leghold traps and snares.

These recent victories for wildlife still leave much to be accomplished – for example, many conservationists are pushing the new commission to go much further in restricting or banning trapping on public lands. Yet these recent steps toward managing wildlife in an ecologically conscious way give us hope for what we can accomplish in the new year, and the years that follow.

As Leopold wrote in the January 1918 *Pine Cone*, when AWF had successfully achieved its goal of a nonpolitical game warden: "While the wild life of New Mexico is far from saved, its ultimate preservation is at least brought within the bound of possibility."

## DECEMBER 12, 2019: Annual Holiday Potluck & Members Meeting

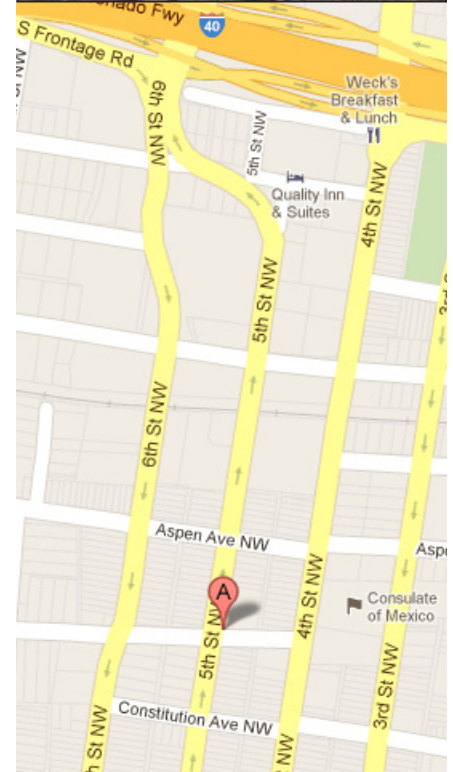
*Join us for our annual holiday potluck to celebrate another successful year of restoring our public lands!*

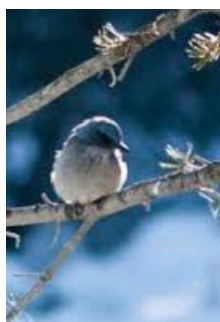
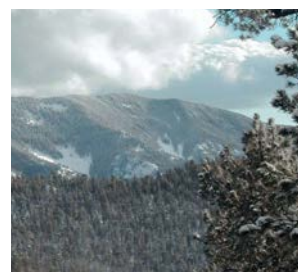
