Saving New Mexico's Endangered Rivers

Every year, the national nonprofit American Rivers highlights a handful of the nation's most endangered rivers, in the hopes that shining a spotlight on the threats to these waterways will inspire people to protect them.

This year, for the first time in the 40-year history of the ranking, the most endangered river is not a single river: it is the "Rivers of New Mexico." All of them.

In past years, individual New Mexico rivers have been listed as most endangered due to specific threats: the Rio Gallinas due to impacts from the Calf Canyon-Hermit's Peak Fire, the Pecos River due to proposed hardrock mining, the wild Gila River due to a proposed dam.

The reason that *all* of New Mexico's rivers topped the list this year is because of a recent Supreme Court decision, *Sackett vs. EPA*, which stripped Clean Water Act protections from 95% of New Mexico's waters. As a result, federal law no longer prevents pollution being dumped into most of our state's rivers and streams, or shields our wetlands from being drained or filled.

With the Clean Water Act effectively dead in New Mexico, the only way to protect our waters is with state law. And there is hopeful news on the horizon: during

this year's legislative session, lawmakers appropriated \$7.6 million to the New Mexico Environment Department to develop a state-level permitting and pollution prevention program.

It's a promising start to address the threat to our rivers, but there is still a long road ahead: developing a whole new state water protection program will take time (NMED hopes to launch it in 2027), and it will only be effective if future governors and legislatures continue to fund and support it. With climate change projected to reduce New Mexico's overall water supply by about 25% over the next five decades, we urgently need to keep our water clean and drinkable for humans and wildlife alike.

So as you prepare to vote in this year's legislative elections (the primary is coming up June 4!), be sure to ask your candidates to pledge their support for protecting New Mexico's endangered rivers.

MAY 17-19, 2024 SERVICE PROJECT: Rio Mora Wildlife Refuge

LOCATION: Rio Mora National Wildlife Refuge near Las Vegas, NM

THE PROJECT: This month, AWF is excited to be returning to one of our favorite project sites: the Rio Mora National Wildlife Refuge. The refuge was established in 2012 with the goal of protecting and restoring riparian and grassland habitat for the benefit of a wide variety of species, including burrowing owl, mountain plover, Southwestern willow flycatcher, aquatic species, and migratory grassland and woodland birds.

AWF volunteers have participated in restoration activities on the property for many years. This year, we will continue our work hand-building rock restoration structures to help hold water on the landscape and make the habitat even better for wildlife.

SCHEDULE: Friday, May 17 – Sunday, May 19

Volunteers do not need to be present for the entire weekend to participate. You are welcome to join us just for the work day Saturday, or to camp for just one of the two nights.

On Saturday evening, Brian Miller will share a brief "campfire story" about the history of Rio Mora and its transitions from Native land to fort (and former governor's residence) to ranch to wildlife refuge.

On Sunday from 9:00-1:00 AWF is hosting a special training workshop with Bill Zeedyk focused on learning how to read the landscape and develop a restoration plan, deciding which structures to build and where and how to build them to achieve restoration goals. When you RSVP, please indicate whether you plan to attend the Sunday training.

We are also seeking volunteers to assist with staging rock at the project site earlier in the day on Friday. Please let us know if you would be interested in helping with that and we'll be in touch with more details.

GEAR: Bring everything you need for a weekend of camping and restoration work, including work gloves, hat, long sleeves, long pants, sturdy boots, and sunscreen. We recommend bringing a change of shoes, and waterproof boots or boots you don't mind getting wet. Rain gear, layers, warm clothes for the evenings and plenty of water are essential.

MAY 31-JUNE 2, 2024 SERVICE PROJECT: Rito Peñas Negras

LOCATION: Rito Peñas Negras in the Jemez Mountains

THE PROJECT: Join AWF for our first project at a new site, the Rito Peñas Negras on the west side of the Jemez Mountains. We will be partnering with Rio Grande Return to build structures that will remediate headcuts and prevent water from draining along trails and causing erosion.

Volunteers do not need to be present for the entire weekend to participate. You are welcome to join us just for the work day Saturday, or camp for just one of the two nights.




In mid-April, AWF returned to Ft. Union Ranch, a 90,000-acre property that is being managed with a focus on conservation and good range management. AWF and the Hermit's Peak Watershed Alliance have collaborated on restoration projects on this property since 2018, repairing damage caused by many years of wagon roads and heavy grazing during the years Fort Union was active in the late 1800s.

This year we worked at a new site, a spring-fed tributary of the Needham Arroyo in the Turkey Mountains, which flows into Wolf Creek. Over the course of the weekend, volunteers built a series of 26 rock restoration structures—one-rock dams, a media luna, and a Zuni bowl—to stop the gully from downcutting. Volunteers also spread juniper cuttings on raw banks to hold moisture, cool the soil, and encourage the growth of vegetation.

We were pleased to welcome volunteers from Gallup, Ojo Caliente, Ruidoso, Taos, and even Gardner, CO as well as Santa Fe, Albuquerque, and Las Vegas, NM. First-time volunteer Raena Kamakahi from the New Mexico Land Conservancy brought information about her work on conservation easements on Ft. Union Ranch, and, along with her partner Noah Duncan, a delicious array of vegan offerings for the potluck and breakfasts. We look forward to partnering again with Hermit's Peak Watershed Alliance for a project in Gallinas Canyon in July, and to returning to Ft. Union to continue enhancing the health of this landscape for many years to come.


